PREPARATION FOR USE

General

- Always inspect the appliance before use to ensure the trimmer blades are free from hair, debris etc.
- Use on clean, dry hair that has been combed until tangle-free.

Oiling Instructions

- For optimum cutting performance, it is highly recommended to oil the blades after every use.
- When using the oil for the first time, unscrew the cap and cut off the very end of the plastic tube with a pair of scissors.
- Remove the blade guard and switch the appliance on.
- Holding the trimmer at a 45 degree angle, gently squeeze the oil tube and apply 2 drops directly onto the blades.
- Leave the unit on for a further few seconds to allow the oil to thoroughly spread along the length of the blades.
- Switch off the unit and remove any excess oil by gently dabbing with a cloth before using on hair.

Charging the Appliance

Charging the Appliance

- Before using the appliance for the first time, charge the battery continuously for 3 hours. Maximum battery capacity will only be reached after 3 completed charging and discharging cycles.
- Plug the charging adapter into a suitable mains power socket and connect to the unit and switch on. The LED indicator light will flash when correctly connected to the mains power and will continuously flash until the battery has fully charged. When the battery is fully charged the LED indicator light will stop flashing but remain on.

NOTE: Always place the trimmer in the base with the 'I/O' switch in the OFF position.

- When the trimmer is running low on charge, the LED indicator light will flash, warning there is approximately 3 minutes of battery use remaining. A 3 hour charge will provide approximately 4 hours use.
- If the charging light starts to flash rapidly (more than 4 flashes per second) then the appliance is faulty. If this happens then please stop charging and remove the adapter from the mains and contact the

Conair Customer Care Line. (See 'UK After Sales Service' section for further information).

Preserving the Batteries

- In order to maintain the optimum capacity of the rechargeable batteries, the appliance should be recharged for 3 hours approximately every 6 months.
- Using the trimmer on the mains ensure that the trimmer is switched off. Plug into a suitable mains socket. Wait for approximately a minute, and then switch on.

IMPORTANT: Do not use the trimmer in this mode for more than 20 minutes.

REMOVING AND REPLACING THE BLADE


Ensure the trimmer isn't connected to the mains and is switched off. Turn the trimmer upside down so that the teeth of the trimmer are facing down. Place the trimmer on a flat surface and using the screwdriver, loosen the fastening screws from the blade. Remove the blade from the trimmer (Fig. 1).



To install or replace your trimmer blade, reverse the procedure, aligning the blade cushion shaft into the moving blade cushion (Fig. 2). With the blade held in place, replace blade screws and tighten loosely. Turn the trimmer over and align the blade set parallel to the trimmer's upper housing.





ZERO GAP ADJUSTMENT TOOL

IMPORTANT! Only attempt to zero gap the blades by using the adjustment tool and following the instructions very precisely.


The adjustment tool is required to adjust the blades to zero gap, which will achieve a closer, more precise cut.

- Step 1 Using the screwdriver included, gently loosen the two small screws on each side of the blade.
- Step 2 Slide the zero gap tool over the gold fixed blade until it is tight against the back portion of the moving cutting blade.
- Step 3 Using your fingers on each side of the zero gap tool, push up until the cutting blade is even with or slightly below the fixed blade.







Be sure that the blades are aligned properly. The teeth of the smaller blade (cutter) should rest slightly below the upper edge of the larger blade (comb) — approximately 0,5 mm to 1 mm apart (Fig. 3). If the blades are not correctly aligned, they may cut or scratch your skin when trimming. Once the blades have been aligned, tighten the screws firmly.



 Step 4 – WARNING! Make sure the moving cutting blade doesn't extend past the fixed blade. If the cutting blade extends past the fixed blade it can potentially cut the skin.



 Step 5 – Once the blade is adjusted to zero gap or your liking, gently tighten the two screws on each side of the blade while holding the zero gap tool in place. If the blade is not adjusted to satisfaction after testing, repeat the adjusting process.



Cleaning & Maintenance

- To maintain optimum performance, the appliance should be cleaned after each use.
- Blow away any remaining hair on the blades or use the cleaning brush provided.
- Oil the blades after every use to ensure optimum cutting performance.

IMPORTANT: Blades must be cleaned and oiled on a regular basis for proper functioning. Failure to regularly clean and oil the blades will void the guarantee.

DO NOT RINSE BLADE, TRIMMER HANDLE OR ADAPTER
