 WARNING! Do not use this appliance near bathtubs, showers, basins or other vessels containing water.



- Do not immerse the appliance in water or other liquids.
- Keep the appliance dry.
- **UK Only:** Do not use this appliance in the bathroom.

- Outside the UK: If using the appliance in a bathroom, unplug after use as the proximity of water can be dangerous even if the appliance is switched off. For additional protection the installation of a residual current device (RCD) with a rated residual operating current not exceeding 30mA is advisable in the electrical circuit supplying the bathroom. Ask your installer for advice.
- The appliance's charging stand and/or adaptor must be kept away from sources of water so that they do not fall into the water.

- Do not leave the appliance unattended when switched on.
- Do not leave the appliance plugged in for more than 24 hours.
- Unplug immediately if any problems occur during use.
- Do not place the appliance on any surface whilst in operation.


ON/OFF SWITCH

To operate, simply slide switch to «I» position. To stop operation, set to the «0» position. Make sure the switch is in the OFF ("0") position when the trimmer is not being used.

VERY IMPORTANT: BLADES MUST BE CLEANED AND OILED ON A REGULAR BASIS FOR PROPER FUNCTIONING. FAILURE TO REGULARLY CLEAN AND OIL THE BLADES WILL VOID THE WARRANTY.

REPLACING (REMOVING) BLADE SET

To remove the blade set, turn the trimmer to the OFF position and unplug it from the electrical outlet. Turn the trimmer upside down so that the teeth of the trimmer are facing down. Place the trimmer on a flat surface and using the screwdriver, loosen the fastening screws from the blade set. Remove the blade set from the trimmer (see Fig. 1).



To install or replace your trimmer blade set, reverse the procedure, aligning the blade cushion shaft into the moving blade cushion (see Fig. 2). With the blade held in place, replace blade screws and tighten loosely. Turn the trimmer over and align the blade set parallel to the trimmer's upper housing.

BLADE CARE

Because the trimmer blades are precision-made they should always be handled with care and cleaned regularly to ensure maximum performance. Each time you finish using the trimmer, take the cleaning brush provided and brush away any loose hair that has collected in the blades. Use a clean cloth to dry the attachment, reattach and then store the trimmer to protect the blades until the next use.

Any other servicing should be performed by an authorized service representative, since the appliance has no other user-serviceable parts.


DO NOT RINSE BLADE, TRIMMER HANDLE OR ADAPTOR AND REPLACING THE BLADE

Ensure the trimmer is switched off. Turn the trimmer upside down so that the teeth of the trimmer are facing down. Place the trimmer on a flat surface and using the screwdriver, loosen the fastening screws from the blade. Remove the blade from the trimmer (Fig. 1).



To install or replace your trimmer blade, reverse the procedure, aligning the blade cushion shaft into the moving blade cushion (Fig. 2). With the blade held in place, replace blade screws and tighten loosely. Turn the trimmer over and align the blade set parallel to the trimmer's upper housing.








ZERO GAP ADJUSTMENT TOOL

IMPORTANT! Only attempt to zero gap the blades by using the adjustment tool and following the instructions very precisely.


The adjustment tool is required to adjust the blades to zero gap, which will achieve a closer, more precise cut.

- Step 1 Using the screwdriver included, gently loosen the two small screws on each side of the blade.
- Step 2 Slide the zero gap tool over the fixed blade until it is tight against the back portion of the moving cutting blade.
- Step 3 Using your fingers on each side of the zero gap tool, push up until the cutting blade is even with or slightly below the fixed blade.







Be sure that the blades are aligned properly. The teeth of the smaller blade (cutter) should rest slightly below the upper edge of the larger blade (comb) — approximately 0,3 mm to 0,5 mm apart (Fig. 3). If the blades are not correctly aligned, they may cut or scratch your skin when trimming. Once the blades have been aligned, tighten the screws firmly.



 Step 4 – WARNING! Make sure the moving cutting blade doesn't extend past the fixed blade. If the cutting blade extends past the fixed blade it can potentially cut the skin.



 Step 5 – Once the blade is adjusted to zero gap or your liking, gently tighten the two screws on




BATTERY REMOVAL AND INSTALLATION

The FX729U trimmer features a removable, rechargeable, and interchangeable battery, so you can cut and style for extended amounts of time with minimal interruption. Be sure trimmer is in the OFF ("0") position before removing or installing the battery.

1. To remove the battery, press on the battery release button on the back of the trimmer handle toward the middle of the unit



- 2. The battery will partially eject but needs to be pulled from the bottom of the trimmer to remove completely.
- 3. To install the battery, line up the keyway of the trimmer with the battery housing, aligning the arrow mark on the battery with the arrow mark on the trimmer. Insert the battery into the opening and push into the housing until the locking mechanism engages.



WARNING – Make sure the trimmer and battery are aligned properly before pushing battery all the way in. Do not force battery in if any resistance is felt.

DISPOSAL OF LITHIUM-ION BATTERIES

- 1. The batteries for this trimmer set are protected in a plastic housing.
- 2. Press the battery release button and pull battery housing out of trimmer
- 3. No further disassembly of the battery unit is required.
- 4. Take to an authorized battery recycling center and recycle entire battery unit.

IMPORTANT

Do not use this appliance with a damaged or broken comb, as it has the potential to result in facial injury.

Always attach plug to appliance first, then to outlet. To disconnect, turn all controls to off position (e.g. "0") then remove plug from outlet. Keep the appliance cord away from heated surfaces.

Make sure the switch is in the OFF "0" position when the trimmer is not operating.

Plug charging stand into outlet to charge batteries. To disconnect, first remove batteries from charging stand, then unplug from outlet.

Use of a charging stand not sold by BaBylissPRO may result in risk of fire, electric shock, or injury to person.

Do not disassemble charging stand. Incorrect reassembly may result in a risk of electric shock or fire. When repair is required, send or take it to a BaBylissPRO Authorized Service Center.

The batteries for this trimmer are designed to be easy to use. However, like all batteries, they will eventually wear out. Do not attempt to replace the batteries. When replacement is required, contact a BaBylissPRO Authorized Service Center.

Batteries can be harmful to the environment if disposed of improperly. Many communities offer recycling or battery collection. Contact your local government about disposal practices in your area.

WARNING: never touch both terminals on trimmer with metal objects and/or body parts, as short circuit may result.

CHARGING STAND INSTRUCTIONS

The FXONE Universal Battery Charging Stand can be powered by either the universal FXCORD (not included) or a USB-C adaptor.

To use a USB-C adaptor: Connect the USB-C adaptor to the USB-C port at the back of the FXONE Universal Battery Charging Stand, then insert the battery into the charger.

To use the universal FXCORD: Connect the standard charging cord (FXCORD) to the standard port at the back of the FXONE Universal Battery Charging Stand, then insert the battery into the charger.


To insert the battery into the charging stand: Align the arrow mark on the battery with the arrow mark on the charger, then insert the battery into the opening and push into the housing until the locking mechanism engages.


Warning: Only use with FXCORD AC adaptor CA78M (not included) or USB-C adaptor CA88M provided with the appliance.

BATTERY/CHARGING INDICATOR (TOP OF FXONE BATTERY)

Blue flashing - Charging

Blue solid - Charged (see charge levels below)

- The charging stand may become warm while charging. This is normal.
- Preserving the battery: In order to maintain the optimum capacity of the rechargeable battery, it should be recharged for 3 hours approximately every 6 months.

WARNING: If the charging light suddenly starts to flash rapidly, the battery is faulty. If this happens, stop charging, unplug the FXONE Universal Battery Charging Stand from the outlet/USB power source and contact our Customer Care Center for further advice.

BATTERY CHARGE-LEVEL INDICATOR

The FXONE Universal Battery has a built-in 4-stage LED ring light to indicate charge level of the battery. To check charge level, press on the central button on the bottom of the battery housing to display current charge level.

Full circle – 100% charge 4 circle – 75% charge 2 circle – 50% charge 4 circle – 25% charge



Read these instructions carefully before connecting the charging stand to any power supply. OPERATION

- 1. For dry use only. Do not expose to water.
- 2. When not in use, unplug unit completely.
- 3. Unit will become warm during operation.


