- **WARNING!** Do not use this appliance near bathtubs, showers, basins or other vessels containing water.
- Do not immerse the appliance in water or other liquids.
- Keep the appliance dry.
- **UK Only:** Do not use this appliance in the bathroom.
- Outside the UK: If using the appliance in a bathroom, unplug after use as the proximity of water can be

dangerous even if the appliance is switched off. For additional protection the installation of a residual current device (RCD) with a rated residual operating current not exceeding 30mA is advisable in the electrical circuit supplying the bathroom. Ask your installer for advice.

- The appliance's charging stand and/or adaptor must be kept away from sources of water so that they do not fall into the water.
- **CAUTION!** Keep the power cord and the appliance dry.

ON/OFF SWITCH

To operate, simply slide switch to ON (marked «I»). To stop operation, set to the OFF (marked «0») position. Make sure the switch is in the OFF ("0") position when the clipper is not being used.

VERY IMPORTANT: BLADES MUST BE CLEANED AND OILED ON A REGULAR BASIS FOR PROPER FUNCTIONING. FAILURE TO REGULARLY CLEAN AND OIL THE BLADES WILL VOID THE WARRANTY.

USER MAINTENANCE INSTRUCTIONS

MAINTENANCE OF THE BLADE

Always apply oil to the blades before and after use. This will ensure maximum cutting performance and proper maintenance. Hold the clipper away from your body in a downward position and apply a drop of BaBylissPRO lubricating oil on the front and sides of the cutter blade. Wipe off excess oil with a soft, dry cloth.

Do not pull, twist, or wrap the power cord around the appliance.

HOW TO USE COMB ATTACHMENTS


To use the comb attachments, turn the clipper to the «0» (OFF) position. Slide the comb attachment onto the top of the clipper blade, and then pull down and over the back of the blade. To remove, pull up on the back of the comb attachment and then pull away from the blade.

REPLACEMENT (REMOVAL) OF BLADE SET

Step 1. Unplug the unit and adjust the taper (see position in illustration A).



Step 2. Remove the screws and the fixed blade. Save the screws.

Step 3. Lift off the small moving blade and replace it with the new one on the plastic oscillator (see illustration B).

Step 4. Replace the fixed blade using the screws and lightly tighten them. Adjust the teeth, as shown in illustration C, to a gap of 0.3mm to 1.0mm. The small, moving blade should be as centered and as parallel as possible to the fixed blade's teeth.


IMPORTANT NOTE:

The top edge of the fixed blade must be a minimum of 0.3mm higher than the top edge of the moving blade and as centered as possible. This is important so that the moving blade does not come in contact with the skin.

Be sure to add a few drops of BaBylissPRO lubricating oil to the blades before running the clipper. Don't forget to tighten the screws after the blades have been aligned.


BLADE SHARPENING

BaBylissPRO cutting blades are ground from the finest quality graphite and are hardened to extend the cutting performance. As with any cutting appliance, the cutting edges become dull from repeated use. Increasing blade tension to force the blade cutting would cause the clipper to overheat and reduce its motor life. When the blade is no longer able to cut smoothly, sharpening is required or replace it with a new BaBylissPRO blade set.



ADJUSTABLE TAPER LEVER

The taper lever is positioned at your thumb. You can hold the clipper in your hand and adjust the lever while you are clipping.




The taper lever adjusts the closeness of the cut—from a close cut with the taper lever in the up position to a longer length cut with the taper lever in the down position. To increase cutting length, slowly push the lever down. To cut closer, push the lever up. As different cutting edges are used in each setting, using the taper lever lengthens the life of the clipper blades. Hair buildup can slow down the clipper. Keep the clipper on for removing hair. Then push the taper lever back and forth quickly several times. If you do this every time, especially after cutting a lot of hair, the clipper blades should remain free of cut hair. Oil the blades after the above procedures.


BATTERY REMOVAL AND INSTALLATION

The FX829U clipper features a removable, rechargeable, and interchangeable battery, so you can cut and style for extended amounts of time with minimal interruption. Be sure clipper is in the OFF ("0") position before removing or installing the battery.

1. To remove the battery, press on the battery release button on the back of the clipper handle toward the middle of the unit



- 2. The battery will partially eject but needs to be pulled from the bottom of the clipper to remove completely.
- 3. To install the battery, line up the keyway of the clipper with the battery housing, aligning the arrow mark on the battery with the arrow mark on the clipper. Insert the battery into the opening and push into the housing until the locking mechanism engages.



WARNING – Make sure the clipper and battery are aligned properly before pushing battery all the way in. Do not force battery in if any resistance is felt.

DISPOSAL OF LITHIUM-ION BATTERIES

- 1. The batteries for this clipper set are protected in a plastic housing.
- 2. Press the battery release button and pull battery housing out of clipper
- 3. No further disassembly of the battery unit is required.
- 4. Take to an authorized battery recycling center and recycle entire battery unit.

IMPORTANT

Do not use this appliance with a damaged or broken comb, as it has the potential to result in facial injury.

Keep the appliance cord away from heated surfaces.

Make sure the switch is in the OFF "0" position when the clipper is not operating. Plug charging stand into outlet to charge batteries. To disconnect, first remove batteries from charging stand, then unplug from outlet. Use of a charging stand not sold by BaBylissPRO may result in risk of fire, electric shock, or injury to person.

Do not disassemble charging stand. Incorrect reassembly may result in a risk of electric shock or fire. When repair is required, send or take it to a BaBylissPRO Authorized Service Center. The batteries for this clipper are designed to be easy to use. However, like all batteries, they will eventually wear out. Do not attempt to replace the batteries. When replacement is required, contact a BaBylissPRO Authorized Service Center. Batteries can be harmful to the environment if disposed of improperly. Many communities o er recycling or battery collection. Contact your local government about disposal practices in your area. WARNING: Never touch both terminals on clipper with metal objects and/or body parts, as short circuit may result. Keep away from children. Failure to comply with these warnings could result in fire or serious injury. This clipper is intended for trimming purposes only.

CHARGING STAND INSTRUCTIONS

The FXONE Universal Battery Charging Stand can be powered by either the universal FXCORD (not included) or a USB-C adaptor.

To use a USB-C adaptor: Connect the USB-C adaptor to the USB-C port at the back of the FXONE Universal Battery Charging Stand, then insert the battery into the charger.

To use the universal FXCORD: Connect the standard charging cord (FXCORD) to the standard port at the back of the FXONE Universal Battery Charging Stand, then insert the battery into the charger.


To insert the battery into the charging stand: Align the arrow mark on the battery with the arrow mark on the charger, then insert the battery into the opening and push into the housing until the locking mechanism engages.

Warning: Only use with FXCORD AC adaptor CA78M (not included) or USB-C adaptor CA88M provided with the appliance.

Rated Output:

Universal FXCORD CA78M: 4.5VDC, 1.2A (not included)

USB-C adaptor CA88M: 5.0VDC, 2.0A



BATTERY/CHARGING INDICATOR (TOP OF FXONE BATTERY)

Blue flashing - Charging

Blue solid – Charged (see charge levels below)

- The charging stand may become warm while charging. This is normal.
- Preserving the battery: In order to maintain the optimum capacity of the rechargeable battery, it should be recharged for 3 hours approximately every 6 months.

WARNING: If the charging light suddenly starts to flash rapidly, the battery is faulty. If this happens, stop charging, unplug the FXONE Universal Battery Charging Stand from the outlet/USB power source and contact our Customer Care Center for further advice.

BATTERY CHARGE-LEVEL INDICATOR

The FXONE Universal Battery has a built-in 4-stage LED ring light to indicate charge level of the battery. To check charge level, press on the central button on the bottom of the battery housing to display current charge level.

Full circle – 100% charge 4 circle – 75% charge 2 circle – 50% charge 4 circle – 25% charge



Read these instructions carefully before connecting the charging stand to any power supply. OPERATION

- 1. For dry use only. Do not expose to water.
- 2. When not in use, unplug unit completely.
- 3. Unit will become warm during operation.

CLIPPER OPERATING PRECAUTIONS

This Clipper has a removable rechargeable battery. Do not throw device or battery into fire, apply heat, or charge, use, or leave in a high-temperature environment.

If the clipper is to be stored unused for a long period, the FXONE Universal Battery should be removed.
